Membership Fact Sheet

Thank you for your interest in submitting your child for representation by **Wildcats Kids Management** for the directory in 2012. Wildcats Kids Management are a children & young performers agency for students of Wildcats Theatre School - and is being led by our dedicated staff team.

Full membership to Wildcats Kids Management will cost £150.00 per year, including submission to the Spotlight Directory.

Benefits of Membership

- ★ All members of **Wildcats Kids Management** will be submitted into the Spotlight Children & Young Performers Directory 2012 (provided their application reaches us by 1st November 2011).
- ★ All members of **Wildcats Kids Management** will be put forward for suitable auditions and performance opportunities throughout their membership. If successful in their application, **Wildcats Kids Management** will apply for any necessary child work licenses on your behalf.
- ★ **Wildcats Kids Management** provide guidance and mentoring for auditions, assignments and any other work-related issue for all children we represent.
- ★ All **Wildcats Kids Management** staff are licensed chaperones and in the case of a parent being unavailable, we can provide this service when required. For every assignment a child receives, they will require either a parent or chaperone present. Depending on the location of work, a small fee for fuel may be payable if you wish to use this service.
- ★ Children represented by **Wildcats Kids Management** will have a dedicated page on our website with their casting information included.
- ★ **Wildcats Kids Management** offer dedicated support for all applications, through their staff team. We can offer support with all stages of your application, from completing the form to conforming & approving your head shot.
- ★ Children represented by **Wildcats Kids Management** are eligible for reduced rates on head shot photography and voice-clip / showreel creation either through our own in-house services or our network of industry professionals.

Some Things You Should Know

Your child must be between the ages of 5 and 20 years old and must be a current student at **Wildcats Theatre School** to apply for representation with **Wildcats Kids Management**.

Wildcats Kids Management is **not** a casting agency. It is a management team of committed professionals who work only with students at **Wildcats Theatre School**. The services we offer are listed on the previous page.

As we teach the children ourselves, we know the children well. We know their strengths and can select appropriate assignments from the Spotlight directory of castings. We will never put your child forward for an audition that they are not suitable for.

Our membership fee of **£150.00 per year** breaks down as follows:

- £90.00 annual Spotlight entry fee
- £5.00 per calendar month management fee

Our management fee includes:

- a) creating and maintaining your child's online Spotlight CV & print entry
- b) creating and maintaining your child's page on the WKM website and database
- c) promotion of your child through professional networks (as detailed below)
- d) arranging work permits and necessary licenses for work

For any assignments that **Wildcats Kids Management** arrange for your child, we charge a set commission rate of 12% of the assignment fee before tax. This is a non-negotiable figure and is set in line with other commercial talent management companies.

We have a dedicated WKM Consultant whose primary job is to work to promote the children throughout the industry. With links to many production houses including Objective Productions, ITV Studios and the BBC among others, **Wildcats Kids Management** not only apply for castings through the Spotlight Casting service, but direct to employers also.

Whilst **Wildcats Kids Management** will put children forward for auditions and castings, in the majority of cases this will be done directly with the employer / casting director. In other cases, this may be done through a third party such as a Casting Agency who, at each assignment, will advise of rates and commission. In this case, our commission rate will be halved to 6% of assignment fee before tax.

For any work that **Wildcats Kids Management** arrange for your child, you are bound by the terms and conditions set out on the application form and available on our website as an additional download.
